EARLY CHILDHOOD SAFETY INITIATIVE



Washington County FCF was awarded a com- ${\rm Ohio\,Children}^*{\rm Trust\,Fund} \mbox{ petitive Early Childhood Safety Initiative grant}$ from the Ohio Children's Trust Fund for SFY 24. The \$50,000 grant offers families in Help Me

Grow, as well as any family under 200% FPL with a child under age 2, a Safety Kit. The kit includes child-proofing products and a stroller, along with a safety education presentation. Help Me Grow families can also receive additional safety items based on specific needs identified.

NO WRONG DOOR INITIATIVE

Family & Children First launched our No Wrong Door (NWD) Initiative in 2023, as a result of Council's Shared Plan to increase resource awareness. Social services systems can be chal-Help Wherever You Turn lenging to navigate and understand, sometimes causing people to feel rejected or frustrated in

their efforts to obtain help. That's why the NWD philosophy promotes a practice that when people need help, they're connected with the desired services, regardless of which agency they call or the door they enter. Thus, every health and human services door would be the right one, with a range of information and referrals accessible to everyone who enters. Council sought support from county agencies and organizations who were committed to the mission to make every door the right door. 16 organizations pledged their support to become actively involved, and identified a Navigator from their system. These Navigators formed the Cross-Systems Training (CST) Team that meets monthly to develop and promote NWD and trainings for county staff. Anyone is welcome to join the CST Team! Navigators also serve as the resource go-to person in their agency and between partners.

Trainings are an integral part of the NWD process and our first virtual Lunch & Learn Training was held in November and will continue on the first Thursday of each month, with different presenters. A Social Services 101 training for newer employees, and other trainings are planned for the future. Trainings are open to all agencies/organizations staff interested in broadening their knowledge on county resources, in order to assist clients.

We are excited to grow this Initiative to encompass all service providers. The goals include: better service to families; improve staff and client satisfaction: and reduce stressors for clients!

PARENTING PROGRAMS and MORE...

Washington County Family & Children First offers several Parenting *Programs free to the public. They include:*

Families PROGRAM FOR PARENTS AND YOUTH 10-14

STRENGTHENING Strengthening Families 10-14 Program is the #1 evidence-based parenting program that reduces substance abuse in youth. Trained Facilitators pre-

sent the 7-week program to parents and their youth between ages 10 -14 with family strengthening activities. A family meal, child care, transportation and a gift basket are available free to all participants. The program is funded through the Washington County Behavioral Health Board. 12 parents and children served in CY 2023



Incredible Years Preschool Basic 3-6 Program is an evidence-based parenting program that strengthens parent-child interactions and attachment; reduces harsh

discipline; and fosters parents' ability to promote children's social, emotional and language development. Facilitators present the 14-week IYP program to parents with children ages 3-6. A meal, child care and transportation are provided. The program is funded through the Washington County Behavioral Health Board.

Parenting Wisely (PW) is an evidence-based interactive CD Rom program that is accessed individually at a computer and completed in a 2-3 hour session. PW provides skills that help in communicating and lowering children's risks for problems. Both PW American Teens and PW Young Children are available on an ongoing basis to allow imme-

diate access to parenting skills training. FREE to the public at the FCF office on a weekday basis. 12 sessions completed in CY 2023

CHILD PASSENGER SAFETY FITTING STATION



WHAT WE DO...

SERVICE COORDINATION / WRAPAROUND



Service Coordination offers families of children with multi-system needs the opportunity to bring providers together in a coordinated manner to support and wrap services around the family, enabling youth to thrive in their home and school environment. The Wraparound process is offered to those

with more intense needs when systems and

families 'don't know what else to do'. Trained facilitators develop Family Teams who support family voice and choice, and wrap families in services to prevent removal from the home.

MULTI-SYSTEM YOUTH (MSY) INITIATIVE

Through a Grant Agreement with the Ohio Department of Medicaid (ODM), Family & Children First was able to financially support services to children/youth in our Service Coordination Mechanism Process. These funds target children/youth that have multi-system needs and are at risk for custody relinguishment, and provide much needed services and supports to vulnerable families.

Total MSY ODM funds awarded in CY 2023 was \$114,400

OUT-OF-HOME PLACEMENTS

Family & Children First coordinates services and funding for families whose child has been identified to need temporary out-of-home place-

ment in a residential treatment facility. While our goal is to prevent removal of children from their home, the other goal is for parents to not have to relinquish custody in order to receive services. Fortunately, through the services offered by facilitators in our Wraparound process, parental placements continue to decrease significantly.

PARTNERS SUPPORTING MULTI-SYSTEM YOUTH

FCF is fortunate and grateful to have the added financial support of our local partners, DJFS and the Behavioral Health Board, to support our MSY services to children and youth; as well as the administrative financial assistance from our Pooled Funds Group members: Behavioral Health Board, Children Services, and the Board of Developmental Disabilities.

WHAT WE DO...



Help Me Grow is the umbrella for two programs: Home Visiting through the Ohio Department of Health (ODH), and

Dime Grow Early Intervention through the Ohio Department of Developmental Disabilities (DODD).

Washinaton County FCF receives the Early Intervention Grant from DODD and is the Provider for the ODH Home Visiting Program.



Home Visiting— Home Visiting is a voluntary, confidential program offered to prenatal and new moms. FCF is affiliated with the national Parents As Teachers Home Visiting model. Credentialed Home Visitors provide the Parents As Teachers (PAT) curriculum; referrals and resources; developmental screenings; parenting tools assessments; and a Family Plan. The program serves prenatal moms and children up to age 5.

The 4 goals of the program are:

- To increase healthy pregnancies •
- Improve parenting confidence and competence
- Improve child health, development and readiness ٠
- Increase family connectedness to community and social support

FCF serves as the Home Visiting Provider in both Washington and Morgan Counties.

Department of **Developmental Disabilities**

Early Intervention — Ohio's Early Intervention System serves children from birth to age 3 who have a developmental delay or a diagnosed medical condition likely to cause a delay. Service Coordinators provide screenings. Individualized Family Service Plan development, transition services, referrals/ resources, linkage to specialized services, and coordination of evaluations. assessment, and funding. The goals of the program are:

- To enhance the development of infants and toddlers with disabilities; ٠
- To reduce educational costs by minimizing the need for special ٠ education through early intervention;
- To minimize the likelihood of institutionalization and maximize • independent living;
- To enhance the capacity of families to meet their child's needs

Central Coordination (CC)— Bright Beginnings of Cuyahoga County serves as the contractor for HMG Central Coordination through 7 regional sites. This is the statewide system for referring to the Help Me Grow Home Visiting and Early Intervention programs. 1-800-755-4769
